#### 1. Call to order and accept proof of publication of notice of meeting.

Chairman Ashby called the meeting to order at 4:00 pm. The Board members in attendance were Mr. Keith Bullock, and Mr. Jim Hall. Also in attendance was Virginia Yeagle, Administrator and Michael Stebbins, General Counsel. Board members Mr. Gene Franklin and Ms. Jean Tucker were unable to attend.

Notice of the meeting was published in the BCC weekly meeting notice in the Escambia Sun Press, on the Authority's website, and a meeting notice was posted on the front door at the Authority's office.

#### 2. Approve Minutes of the meeting held on August 27, 2024.

Motion was made by Mr. Hall and seconded by Mr. Bullock to approve the minutes. Motion passed unanimously.

Motion was made by Mr. Bullock and seconded by Mr. Hall to approve the resolution. Motion passed unanimously.

b. Authority Goals and Objectives, performance measures and Standard pursuant to Section 189.0694 Florida Statutes.

Ms. Yeagle presented a draft of Goals and Objective for the Authority for FY 24-25, in accordance with the new requirement under FL. Stat. 189-0694. Mr. Stebbins queried other special districts for see how they are responding to the new requirement. Escambia County Housing Finance Authority responded to Mr. Stebbins query and shared their draft document. Ms. Yeagle stated that she used their structure as a guide, but based the Authority's draft on the mission and purpose of the Authority. Ms. Yeagle asked for Board input on any item presented. A suggestion was made to change the measurement of Goal 3a to read as follows:

"Ensure sufficient investment returns to meet annual operational budget and charitable endeavors"

Motion was made by Mr. Bullock to adopt the Goals and Objectives as presented with the modification to the measurement standard for Goal 3a. Motion was seconded by Mr. Hall to approve. Motion passed unanimously.

Motion was made by Mr. Bullock to not publish the Authority's Goals and Objective on the Authority website yet. The FL Statutes do not require publication on adoption of the Goals and Objectives. However, by December 1, 2025 the Authority must publish an annual report on the Authority's website describing the goals and objective achieve by the Authority as well as the performance measures and standards used by the Authority to make that determination. Also, any goals or objective not achieve must be disclosed. Motion was seconded by Mr. Hall to approve. Motion passed unanimously.
